**Sponsorship Agreement**

This agreement between \_\_\_\_\_ Affiliate, an Affiliate of the USGLL, and \_\_\_\_\_ (hereinafter, "Sponsor") is for the \_\_\_\_\_ Affiliate for the \_\_\_\_\_ Season.

Sponsorship of a team in the \_\_\_\_\_ Affiliate must be, for the Sponsor, out of a sense of duty to help the community. While Sponsorship does afford some benefits, the higher purpose is to help the \_\_\_\_\_ Affiliate impart the values of teamwork, respect, and integrity to the children of the community, so that they may apply these values in their effort to become good citizens as well as good golfers.

Sponsorship of a team in the \_\_\_\_\_ Affiliate does not permit the Sponsor to have any rights or responsibilities in the operation of the \_\_\_\_\_ Affiliate or any team in the \_\_\_\_\_ Affiliate, nor does the Sponsor have any rights or responsibilities in the selection of, coaches or players for any team in the \_\_\_\_\_ Affiliate. Nothing herein shall make us partners or joint ventures. The Sponsor and the \_\_\_\_\_ Affiliate are independent contractors with respect to one another, and neither shall have any authority to represent or bind the other in any manner or to any extent whatsoever, except as specified herein.

For the considerations above, the Sponsor donates \_\_\_\_\_ (USD) to the \_\_\_\_\_ Affiliate, understanding that its donation is to benefit the entire league.

The Sponsor shall have the right to use the following terms in advertisements, posters, brochures, Newsletters, etc.: "Proud Sponsor of the \_\_\_\_\_ Affiliate" and "Sponsor of a team in the \_\_\_\_\_ Affiliate" or "Proud Sponsor of the \_\_\_\_\_ Affiliate" Team

Use of the \_\_\_\_\_ Affiliate logo or any other logo of USGLL is prohibited, unless permission is expressly granted in writing by the USGLL.
